a) Timberwolves program – 2015 Outdoor season

Discussion	Steve: Information as submitted and open to any questions.
	Scott: Evaluations are based on dual age group – are we eliminating
	'playing up'
	Steve: We could have an exceptional player that would move up but having
	dual age groups obviously will produce less instances of players moving up.
	Davis: I'm against dual age groups. I would like to know the advantages and disadvantages of both dual and single.
	Steve: In brief, dual provides an opportunity for more like-skilled and like-
	minded players to be involved. The problem our Association has is mainly
	with the 'second' team; players that are playing up that shouldn't and
	providing competitive events for the team.
	Davis: I coached the 'second' team under this dual age group system – there
	is a real disparity in skills between players; much different than the 'first'
	team and therefore very little development of the players takes place – dual
	age groups is more for 'winning' vs. single age group promotes player
	development.
	Steve: Grouping players based on growth and development as well as skill
	development, strategy, etc. is good and in single age group the better
	players can always move up.
	Craig: With dual age group, a younger player can displace an older player.
	'Second' team with dual age group can provide an alternative to House
	League.

Ted: If we displace an older player with a younger one how many players are we talking about

Saundra: We could have more than two teams in an age category depending upon registration

Scott: I saw this scenario under Joel – I see the dual age group as a 'bad' scenario – there is a big difference between players within a dual age group – 'second' team was always trying to find players – a bit of a nightmare for the coach to administer the team.

Craig: How many teams last year in the single age group were pulling from the House League

Steve: On the boys side it worked fine but on the girls side we needed to pull some girls from House for tournaments.

Garry: The concern I have with the dual age group is team chemistry – we are constantly 'shuffling' the deck each year with the players – hard to coach players as 'cliques' develop – if you have enough good players at a single age group we should be going this route.

Marti: I would like to echo Garry's points – players should play in their own age group

Saundra: Teams shouldn't be pre-judged and have the same grouping every year – there shouldn't be 'cliques' and I don't think there is at the younger age groups – we have a Tech team that has recommended the dual age and our job is to support those efforts.

Barry: If we had sufficient numbers I would support the single age group – but I feel dual accommodates more players in the program.

Mel: if we only have limited numbers what will we do with the extra players Steve: We try to provide something for everyone but it really depends on the numbers

Mel: My fear is we are going to have more players fall through the cracks Ted: 'Cliques' are a concern – does BC Soccer have a preference to one or two year age groups

Steve: It really depends on the Club or Association – BC Soccer will recommend at times where numbers are low but nothing is clearly defined – as an example in our 15-18 House League we combine three ages in order to make sufficient teams for a league

Barry & Scott: passed along emails from Grant and Sonny

Craig: There is no vote for members not in attendance – spoke about our process here and is supporting our Technical committee.

Davis: I question the process the Technical committee went through

Craig: A point of clarity – the Technical committee was asked to review the decision when Steve was bringing forward a recommendation that was different from the committee

Ted: I hear repeatedly the authority of the Technical committee but there is a bias here

Craig: This is a very difficult topic

Steve: It's a question of philosophy

Ted: Is there going to be an exodus from the lower age group

Steve: We discussed this in our Tech meeting the need to have squad based training where there is movement of players up and down – we just don't have the resources as of yet – we need to wait and see our registration numbers and coaches need to be on board with the philosophy.
